A quality program delivers all required elements and a variety of additional elements. Each educational entity offering the approved sequence of courses provides assurance that the course content includes at a minimum the state course description, (available at http://www.isbe.net/career/html/cte_bus_ed.htm), meets the state's minimum requirements for course offerings by program--contain a minimum of two (2) credits of instruction, curriculum aligned to state recognized learning standards and industry standards, career pathway guidance, resources to support program/course delivery (licensed and qualified staff, appropriate facilities, adequate equipment, instructional materials, work-based learning experiences, special populations support services, active affiliated BPA, DECA, or FBLA chapter), articulation/dual credit agreements, documentation of state agency certification or licensing requirements for occupations regulated by law or licensure, and content which prepare students for reflective of current labor and opportunity for cooperative education as a structured capstone course. Foundational courses are suggested to be taught at the 9th and 10th grade levels. Skill level courses are suggested to be taught at the 10th – 12th grade levels----(Updated 5/2016)
